OVERVIEW

The LEADS Mobile is a website for LEADS Certified Law Enforcement. Previously the LEADS Mobile has been referred to as LEOT, LEOT Mobile, LEADS Search, and LEADS. Henceforth the website will be referred to as just LEADS Mobile.

LEADS Mobile is comprised of 2 websites. One for authentication and management of users (LESSA) and the other is for the search (LEADS Search).






PREFERENCES

SECURE ENVIRONMENT

LEADS utilizes Secure Socket Layer (SSL) and Virtual Private Network (VPN) technologies to secure our users. Each LEADS Mobile user will receive VPN software and a security token to login to the LEADS network. Each user will have a personal password and generated number to use during each login. These technologies provide incredible security to Law Enforcement and LEADS data.



RECOMMENDED WEB BROWSERS

Most web browsers work effectively, but some issues have been discovered with Internet Explorer 11. Internet Explorer 11 comes packaged with Windows 8 and Windows 8.1. If you encounter problems, such as buttons not clicking or the page moves to the left, try adding this website to Compatibility View. First choose Compatibility View settings from the menu.
